

Texas DPS Credit Union Holiday Checking Account Giveaway

Official Giveaway Rules

- 1. ELIGIBILITY:** The Holiday Checking Account Giveaway (the "Promotion") is open to legal residents of the 50 United States and District Columbia (excluding Puerto Rico) who are 18 years of age or older as of the time of entry. One entry per household. Entrants must be approved for a checking account and in good standing at the time of the drawing. Voids where prohibited. Texas DPS Credit Union employees, officers, directors and supervisory committee members, and the immediate family members of such persons, are not eligible. The potential winner may be required to show proof of eligibility.
- 2. PROMOTIONAL PERIOD:** The Promotion begins at 12:00 a.m. CST Thursday, November 17, 2022, and ends at 11:59 p.m. CST on Saturday, December 31, 2022 (the "Promotion Period").
- 3. HOW TO ENTER:** The Promotion must be entered by opening a checking account through the Texas DPS Credit Union website (txdpscu.org) or by contacting the credit union via other methods of communication (phone call, email, etc.). The entry must fulfill all Promotion requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Texas DPS Credit Union. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Texas DPS Credit Union. Entries will be received only during each Promotion Period.
- 4. PRIZE:** One (1) \$500 Grand Prize. Gift cards are subject to terms and conditions. All federal, state, and local taxes, and all other costs associated with acceptance or use of the prize, are the sole responsibility of the winner. **RANDOM DRAWING:** One (1) Grand Prize winner will be selected in a random drawing held within one (1) week of the Promotion end date from among all eligible entries. Arrangements for delivery of the Grand Prize will be performed after winner validation. At Texas DPS Credit Union's discretion, any unclaimed prizes may not be awarded.
- 5. ODDS:** The odds of winning each Prize depend upon the total number of eligible entries received during each Promotion Period
- 6. PUBLICITY:** Except where prohibited by law, entry in the Sweepstakes constitutes winner's consent to Sponsor's use of winner's name, hometown, and photograph/likeness for advertising and promotional purposes in any manner of media (including, without limitation, online and in print) in perpetuity and without further payment, consideration, notice, review or consent.
- 7. TERMS & CONDITIONS:** Texas DPS Credit Union reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Promotion should virus, bug, non-authorized human intervention, fraud, or other cause beyond Texas DPS Credit Union's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case Texas DPS Credit Union may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Texas DPS Credit Union. Texas DPS Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers with

or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. Texas DPS Credit Union has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws. Should such an attempt be made, Texas DPS Credit Union reserves the right to seek damages to the fullest extent permitted by law.
